

RESOLUTION NO.: 2014-163

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, SUPPORTING THE OPENING OF NORTHWEST 170 STREET AS A PUBLIC ROADWAY, AND URGING THE FLORIDA DEPARTMENT OF TRANSPORTATION ("FDOT"), THE TOWN OF MIAMI LAKES, AND MIAMI-DADE COUNTY TO PLEDGE THEIR PUBLIC SUPPORT FOR THE OPENING OF THE ROADWAY.

WHEREAS, the City of Hialeah wishes to open that portion of Northwest 170 Street that lies within the boundaries of the City of Hialeah as a public roadway; and

WHEREAS, Northwest 170 Street forms the northernmost boundary of the City of Hialeah, and intersects with I-75, which forms the easternmost boundary; and

WHEREAS, FDOT has jurisdiction over the limited access road over I-75; Miami-Dade County has jurisdiction over the section-lined road; the Town of Miami Lakes has jurisdiction over the area East of I-75; and the City of Hialeah has jurisdiction over the area West of I-75, including I-75; and

WHEREAS, the City of Hialeah urges FDOT, the Town of Miami Lakes, and Miami-Dade County to pledge their public support for the opening of Northwest 170 Street; and

WHEREAS, opening Northwest 170 Street will serve a public purpose and will benefit the public; and

WHEREAS, opening the roadway will allow residents from neighboring areas, including the Town of Miami Lakes and the area of Palm Springs North to have access to Northwest 170 Street.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1. The foregoing facts and recitations contained in the preamble of this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2. The Mayor and the City Council of the City of Hialeah, Florida support the opening of Northwest 170 Street as a public roadway and urge FDOT, the Town

Section 2. The Mayor and the City Council of the City of Hialeah, Florida support the opening of Northwest 170 Street as a public roadway and urge FDOT, the Town of Miami Lakes, and Miami-Dade County to pledge their public support for the opening of the roadway.

Section 3. The City Clerk is hereby directed to transmit a copy of this resolution to the Florida Department of Transportation, District 6, the Town Clerk for the Town of Miami Lakes, and the County Clerk for Miami-Dade County.






