

RESOLUTION NO. 2014-124

RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE MAYOR AND CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY OF HIALEAH, FLORIDA, TO ENTER INTO CONTRACT WITH FLORIDA HOUSING COALITION, INC., A FLORIDA CORPORATION, TO PERFORM AN ASSESSMENT AND PROVIDE TECHNICAL ASSISTANCE FOR THE CITY OF HIALEAH PROGRAMS (CDBG, HOME, CHDO, SHIP, ESG) AND FOR OTHER RELATED FEDERALLY-FUNDED PROJECTS, INCLUDING TECHNICAL ASSISTANCE, IN AN AMOUNT NOT TO EXCEED THE SUM OF SIXTY THOUSAND (\$60,000.00) DOLLARS AND TO ALLOW THE CITY OF HIALEAH THE OPTION TO RENEW THE CONTRACT FOR TWO CONSECUTIVE YEARS.

WHEREAS, the City of Hialeah is required to submit a five year consolidated plan covering fiscal years 2015-2020 and maintain compliance with all state and federally funded projects; and,

WHEREAS, the firm of Florida Housing Coalition, Inc., has experience in state and federally funded projects and programs and has performed technical assistance for the City of Hialeah for its State Housing Investment Partnership (SHIP) programs in a professional, efficient and competent manner for over 19 years; and,


WHEREAS, it is in the best interest of the City to enter into a contract with Florida Housing Coalition, Inc., to conduct an assessment and provide technical assistance with all state and federally funded projects.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The Mayor and City Clerk, as attesting witness, we hereby authorized to enter into a contract with Florida Housing Coalition, Inc., a Florida corporation, to provide an assessment, review records and provide technical assistance for the city of Hialeah programs (CDBG, HOME, ESG, SHIP, CHDO) and for other related federally-funded projects, in an amount not to exceed the sum of sixty- thousand (\$60,000.00) Dollars.

Section 2: The Mayor and City Clerk are hereby authorized to enter in a contract with Florida Housing Coalition, Inc., for two consecutive years to perform these services in the same terms and conditions.




