RECOGNITION IN OUTSTANDING CONTRIBUTIONS OF BANAH INTERNATIONAL GROUP, INC., TO THE CITY OF HIALEAH AND ITS RESIDENTS, WITH THE COST OF SIGNAGE TO BE PAID BY THE APPLICANT.

WHEREAS, the co-designation of that portion of Southeast 10 Avenue, between Hialeah Drive and Southeast 5 Street, Hialeah, Florida, as "BANAH SWEET WAY", presently named "Sweet Way", is in recognition of the outstanding contributions of Banah International Group, Inc. to the City of Hialeah and its residents; and

WHEREAS, that portion of Southeast 10 Avenue, between Hialeah Drive and Southeast 5 Street, is currently named "Sweet Way", in honor of the Sweet Paper Sales Corporation, which declared bankruptcy and is no longer doing business in Hialeah; and

WHEREAS, Banah International Group, Inc. ("Banah"), a sugar producer, recently signed a lease in the City of Hialeah for a 300,000 square foot facility located at 215 Southeast 10 Avenue, which will consist of Banah's warehouses and production and corporate offices; and

WHEREAS, Banah will be creating a minimum of three hundred jobs that will greatly benefit the residents of Hialeah and contribute to Hialeah's economic growth and development and, in turn, contribute to the welfare of our residents; and

WHEREAS, by installing their new facilities in Hialeah, Banah will boost sales for local suppliers, such as gasoline stations, convenience stores, supermarkets and restaurants; and

WHEREAS, the Historic Preservation Board recommended approval of this resolution on January 17, 2012.
