

RESOLUTION NO.: 2014-105

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE TOTALING AN AMOUNT NOT TO EXCEED SIXTY SEVEN THOUSAND ELEVEN DOLLARS AND FORTY-FIVE CENTS (\$67,011.45) FROM THE LAW ENFORCEMENT TRUST FUND - STATE, TO PURCHASE EIGHTY-FIVE (85) COMPUTERS AND RELATED ACCESSORIES FROM SHI INTERNATIONAL CORPORATION AND CDW CORPORATION, THE LOWEST QUOTED VENDORS, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE.

WHEREAS, the Hialeah Police Department Criminal Investigation Division's mission is further the mission of the Police Department by providing the highest possible level of investigative services to the citizens of the City of Hialeah; and

WHEREAS, the City of Hialeah Police Department's Criminal Investigation Division respond to many scenes in which the investigations call for complex and protracted investigations; and

WHEREAS, specific computer intelligence software programs are necessary to conduct these complex and protracted investigations;

WHEREAS, the current computers utilized by the Hialeah Police Department are not compatible with this specific software; and

WHEREAS, it is necessary for the Hialeah Police Department to work with the Information Technology Department to supply the necessary and specific computers and accessories in order for the Criminal Investigation Division to conduct their complex and protracted investigations; and


WHEREAS, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Trust Fund -State; and

WHEREAS, the Chief of Police has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, Section 932.7055, *Florida Statutes*.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1. The Mayor and the City Council of the City of Hialeah, Florida, approve the expenditure of an amount not to exceed sixty seven thousand eleven dollars and forty-five cents (\$67,011.45) from the Law Enforcement Trust Fund – *State*, to purchase eighty-five (85) computers and related accessories from SHI International Corporation and CDW Corporation, the lowest quoted vendors, upon such costs having been approved by the Chief of Police.




