

**RESOLUTION NO. 2014-53**

RESOLUTION TO TERMINATE THE INTERLOCAL AGREEMENT WITH HIALEAH HOUSING AUTHORITY TO UTILIZE THE SERVICES OF A HIALEAH POLICE DETECTIVE TO PERFORM INVESTIGATIVE AND RELATED SERVICES ENTERED ON MARCH 11, 2014 PURSUANT TO HIALEAH, FLA. RESOLUTION 2014-09 (JANUARY 15, 2014).

**WHEREAS**, the City Council adopted Resolution 2014-09 (January 15, 2014) authorizing the Mayor and the City Clerk, as attesting witness, on behalf of the City of Hialeah to enter into an interlocal agreement with Hialeah Housing Authority to utilize the services of a Hialeah police detective to perform investigative and related services in connection with the responsibilities of the fraud department of the Hialeah Housing Authority for a term of one year ending on or about January 14, 2015;

**WHEREAS**, as a result of the impending retirement of the City of Hialeah police detective assigned to perform the functions required by the interlocal agreement and the City's inability to divert the services of another qualified police officer to this position, the City will no longer be able to meet its obligations under the agreement;

**WHEREAS**, the terms of the agreement allow for termination without cause by either party upon notice; and


**WHEREAS**, in order avoid the mutual obligations under the agreement the City of Hialeah and the Hialeah Housing Authority have agreed to terminate the agreement.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The City of Hialeah, Florida hereby terminates the interlocal agreement with Hialeah Housing Authority entered into on March 11, 2014 for the services of a Hialeah police detective to perform investigative and related services in connection with the responsibilities of the Fraud Department of the Hialeah Housing Authority adopted by Hialeah, Fla. Resolution 14-09 (Jan. 14, 2014).






