

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE TOTALING AN AMOUNT NOT TO EXCEED \$5,075.00 FROM THE LAW ENFORCEMENT TRAINING TRUST FUND, FOR THE PURCHASE OF THREE-HUNDRED FIFTY FLORIDA LAW ENFORCEMENT HANDBOOKS MDPD 2013 EDITION FROM LEXIS NEXIS, A *SOLE SOURCE* VENDOR, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE.

**WHEREAS**, the Hialeah Police Department needs to train its officers utilizing the latest version of Florida State Statutes and Miami-Dade County Ordinances so they can effectively enforce laws and county ordinances within the City of Hialeah; and

**WHEREAS**, Miami-Dade County, in conjunction with the Miami-Dade State Attorney, compiles a yearly legal handbook; and

**WHEREAS**, the *sole source* to obtain the 2013 Edition of the Miami-Dade Police Department, Florida Law Enforcement Handbook is Lexis Nexis; and

**WHEREAS**, the cost of three-hundred fifty handbooks to cover all sworn officers and various offices within the Department is five-thousand seventy-five dollars (\$5,075.00); and

**WHEREAS**, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Training Trust Fund; and


**WHEREAS**, the Chief of Police has recommended adoption of this resolution and determined that the proposed expenditure complies with all applicable statutes.

**Section 1.** The Mayor and the City Council of the City of Hialeah, Florida, approve the expenditure of an amount not to exceed \$5,075.00 from the Law Enforcement






