

**RESOLUTION NO. 13-12**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AWARDING THREE-YEAR LICENSES SUBJECT TO ANNUAL COMPLIANCE REVIEW TO MAGIC TOWING & RECOVERY, INC. AND MIDTOWN TOWING OF MIAMI, INC. TO PERFORM POLICE OR CITY-INITIATED TOWING SERVICES ON A ROTATIONAL BASIS; DIRECTING THE LAW DEPARTMENT TO DRAFT AND NEGOTIATE THE LICENSE AGREEMENT; AUTHORIZING THE MAYOR AND THE ACTING CITY CLERK, ON BEHALF OF THE CITY TO EXECUTE SUCH AGREEMENT IN FURTHERANCE THEREOF.

**WHEREAS**, on February 7, 2013, the Selection Committee, comprising of the Director of the Streets Department, Purchasing Agent and the Risk Manager, ranked all the qualified proposers that responded to the Request for Proposal 2012/13-1000-36-002 Police or City-Initiated Wrecker Services, from the highest ranking to the lowest ranking, in descending order as follows: and (1) Magic Towing & Recovery, Inc. and (2) Midtown Towing of Miami, Inc.; and

**WHEREAS**, the Selection Committee recommends that the City Council award Request for Proposal 2012/13-1000-36-002 to Magic Towing & Recovery, Inc. and Midtown Towing of Miami, Inc.; and

**WHEREAS**, the recommendation of the Selection Committee was submitted, without additional comment from the Mayor, to the Hialeah City Council; and

**WHEREAS**, the City of Hialeah finds that it is in the best interest of the City and its general welfare to award a license to the two proposers for the rotation system, alternating company on a weekly rotation.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

**Section 2:** The City of Hialeah, Florida hereby awards three-year license subject to annual compliance review to Magic Towing & Recovery, Inc. and Midtown Towing of Miami, Inc. to perform police or City-initiated towing services on a rotational basis, alternating companies on a weekly rotation.






