

RESOLUTION NO. 13-33

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AUTHORIZING THE MAYOR AND THE ACTING CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO ENTER INTO AN AGREEMENT FOR A TERM OF FIVE YEARS, WITH TWO SUCCESSIVE ONE-YEAR OPTIONS TO RENEW, WITH BETOLLI TRADING CORP., A FLORIDA CORPORATION, DOING BUSINESS AS BETOLLI VENDING, TO OPERATE SNACK VENDING MACHINE CONCESSIONS AT VARIOUS CITY-OWNED PROPERTIES, IN A FORM APPROVED BY THE CITY ATTORNEY, UTILIZING THE PRICING LIST OF A COMPETITIVELY-BID CONTRACT AND AWARD WITH THE CITY OF MIAMI BEACH PURSUANT TO REQUEST FOR PROPOSALS NO. 44-10/11, PROVIDING FOR A MINIMUM ANNUAL REVENUE GUARANTEE OF \$20,000 BASED ON A PERCENTAGE OF SALES TO BE PAID TOGETHER WITH AN ANNUAL INCREASE EQUAL TO THE CONSUMER PRICE INDEX (CPI).

WHEREAS, it is in the best interest of the City of Hialeah to enter into a vending contract with Bettoli Trading Corp., replacing an expired agreement with a former vendor that provided old vending machines with new or recently refurbished vending machines of better quality; and

WHEREAS, it is advantageous to the City to utilizing the pricing terms of the City of Miami Beach competitively-bid vending agreement with the highest-ranked vendor among 27 proposals received.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby incorporated and adopted by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby authorizes the Mayor and the Acting City Clerk, as attesting witness, on behalf of the City, to enter into an Agreement for a term of

five years, with two successive one-year options to renew, with Betolli Trading Corp., a Florida corporation, doing business as Betolli Vending, to operate snack vending machine concessions at various City-owned properties, in a form approved by the City Attorney, utilizing the pricing list of a competitively-bid contract and award with the City of Miami Beach pursuant to Request for Proposals No. 44-10-11, providing for a minimum annual revenue guarantee of \$20,000 based on a percentage of sales to be paid together with an annual increase equal to the Consumer Price Index (CPI).




