

RESOLUTION NO.: 2013-58

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE EXPENDITURE OF LAW ENFORCEMENT TRUST FUNDS – *STATE*, IN AN AMOUNT NOT TO EXCEED \$12,464.00 TO SUPPORT THE 2013 HIALEAH POLICE CADET SUMMER WORK PROGRAM, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE.

WHEREAS, the Hialeah Police Cadet Program is a diversionary program for at-risk, low-income family youths ages 14 through 18; and

WHEREAS, the Hialeah Police Department has sponsored a Summer Cadet Work Program for the last fifteen years; and

WHEREAS, the purpose of the program is to prevent or reduce crime by establishing a rapport between law enforcement officers and disadvantaged youths, and to direct such youths away from criminal mischief by otherwise occupying their time; and

WHEREAS, the Hialeah Police Department desires to sponsor twenty financially disadvantaged Cadets, so they may participate in the Summer Cadet Work Program along with their fellow Cadets; and

WHEREAS, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Trust Fund - *State*; and


WHEREAS, the Chief of Police has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, Section 932.7055, *Florida Statutes*, (2012).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1. The Mayor and the City Council of the City of Hialeah, Florida, hereby authorize the expenditure of Law Enforcement Trust Funds - *State*, in an amount not to exceed \$12,464.00, to support the 2013 Hialeah Police Cadet Summer Work Program, upon such costs

having been approved by the Chief of Police.




