

**RESOLUTION NO. 2013-67**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AUTHORIZING THE MAYOR AND THE CITY CLERK, ON BEHALF OF THE CITY, TO ENTER INTO A USE AGREEMENT WITH FLORIDA NATIONAL UNIVERSITY, INC. TO PROVIDE THE GYMNASIUM AT BUCKY DENT PARK FOR COLLEGE BASKETBALL PRACTICES AND GAMES FROM SEPTEMBER 30, 2013 THROUGH AND INCLUDING FEBRUARY 28, 2014, A COPY OF WHICH IS ATTACHED HERETO AS EXHIBIT "A".

**WHEREAS**, the City of Hialeah and Florida National University, Inc. are so located in relation to each other that it is to the advantage of each to enter into such agreement; and

**WHEREAS**, a use agreement of this nature would be beneficial to the City of Hialeah.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The City of Hialeah, Florida hereby authorizes the Mayor and the City Clerk, on behalf of the City, to enter into a use agreement with Florida National University, Inc. to provide the gymnasium at Bucky Dent Park for college basketball practices and games from September 30, 2013 through and including February 28, 2014, a copy of which is attached hereto as Exhibit "A".





**USE AGREEMENT BETWEEN CITY OF HIALEAH AND FLORIDA NATIONAL UNIVERSITY, INC.**

This agreement is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2013, by and between the City of Hialeah (hereinafter referred to as "CITY"), a municipal corporation of the State of Florida having its principal place of business at 501 Palm Avenue, Hialeah, Florida, and Florida National University, Inc. (hereinafter referred to as "USER"), a Florida corporation having its principal place of business at 4425 West 20<sup>th</sup> Avenue, Hialeah, Florida 33012.

**CONDITIONS OF USE**

1. The CITY agrees to provide the gymnasium at Buck Dent Park at 2250 West 60<sup>th</sup> Street, Hialeah, Florida to the USER for their college basketball practices and games. The USER agrees to pay the CITY as follows: \$1,310.00 prior to September 30, 2013, \$970.00 prior to November 1, 2013, \$1,030 prior to December 1, 2013, \$1,260.00 prior to January 1, 2014, and \$1,110.00 prior to February 1, 2014. The total rental fee owed is \$5,680.00. (See Exhibit "1")

2. This agreement is effective from September 30, 2013 through February 28, 2014. Under no circumstances shall this agreement be renewed, amended, or extended except in a writing executed by both parties. The parties may agree to renew the terms of this agreement for a one-year period; provided, written notice of renewal is agreed to by both parties at least 30 days prior to the expiration of the agreement term.

3. The USER guarantees that no damage will be done to the facility.

4. The USER shall pay the CITY for the cost of any repair, rehabilitation, damage, correction, replacement or restoration of the facility or to defray any other unusual but reasonable expense borne by the CITY as a consequence of this agreement.

5. Either party hereto may terminate this agreement at any time by giving to the other party notice in writing at least 30 days prior to the intended termination date.

6. Any notice or demand, authorized or required under this agreement shall be in writing and shall be sent certified mail to the other party as follows:

7. The USER acknowledges that the USER and its personnel are not employees or independent contractors of the CITY and that the CITY shall not be responsible for providing workers' compensation insurance for any of the USER's personnel. The USER and its employees shall not be an employee of the CITY. It is agreed that the USER and its employees will acquire no rights to tenure, workers' compensation benefits, unemployment compensation

benefits, medical and hospital benefits, sick and vacation leave, severance pay, pension benefits or other rights or benefits offered to employees of the CITY, its departments or agencies.

8. The USER shall indemnify and save the CITY, its officials, employees, agents, representatives and attorneys, from and against any and all claims, liabilities, losses and cause of action which arise out of or in connection with USER's activities under this agreement, including all NEGLIGENT or intentional acts or omissions to act on the part of the USER or any person acting for or on its behalf, and from and against any orders, judgments, or decrees which may be entered and from and against all costs, attorney's fees, expenses incurred at the trial, appellate or administrative level or proceedings and liabilities insured in the defense of any claims or in the investigation thereof.

9. The USER agrees to carry liability insurance coverage in the amount no less than \$1,000,000.00 combined single limit coverage for property damage and bodily injury. The USER shall have its insurer name the CITY as an additional insured on its general liability policy. It is understood that the CITY is not responsible for personal injury or property damage or any loss to the USER, its personnel or property during the term of this agreement. Insurance provided by the USER must provide coverage for personnel and customers attending performances, and individuals on the premises as acquaintances or friends of the USER from liability for loss, damage, injury and claims, whether to person or property, arising incident to USER's use of the premises and agrees to hold the CITY harmless from any damage sustained by it or any of its agents, employees or invited guests, including the patrons during use.

10. The USER shall not cause or permit any damage at Bucky Dent Park. No signs will be affixed to the exterior or interior of the building and no painting, alterations, repairs or modifications, etc., to any part of the building or furnishings will be permitted, unless specifically approved in advance by the CITY's Facility Manager. The cost for replacement of any equipment that is lost or damaged by the USER, its employees or representatives will be the responsibility of the USER. USER shall not cause or permit anything to be done whereby the said premises or equipment therein shall be in any manner injured, marred or defaced; and will not drive or permit to be driven nails, hooks, tacks or screws into any part of said building or equipment contained therein and will not make nor allow to be made any alterations of any kind to said building or equipment contained therein.

11. All keys for the gymnasium at Buck Dent Park shall remain in the possessions of the CITY.

12. All furnishings, fixtures, equipment, and property of every kind and description of the USER and of persons claiming by or through the USER which may be on the facility shall be at the sole risk and hazard of the USER and no part of loss or damage thereto for whatever cause is to be charged to or borne by the CITY.

13. Halls, walkways, fire exits, and driveways will be kept free of obstruction.

14. This agreement may be modified or amended only in writing by mutual consent of both parties.

15. The USER shall not assign or transfer its interest in the agreement without the written consent of the CITY.

16. In the event that Bucky Dent Park is rendered unsuitable for the music program by fire, hurricane, tropical storm or other acts of God, national or local calamity, act of War, riot or emergency or any unforeseen occurrence or labor dispute, including strikes or lockouts by persons employed by either party, which shall render fulfillment of this agreement by the CITY impossible, the CITY shall not be held legally responsible by USER for any damages caused thereby.

17. This agreement shall be construed in accordance with the laws of the State of Florida. Any dispute with respect to this agreement is subject to the laws of the State of Florida, Miami-Dade County, Florida. Each party shall be responsible for its own attorney's fees and costs incurred as a result of any action or proceeding under this agreement. If either party brings any action or legal proceeding for damages for an alleged breach of any provision of this agreement or to enforce, protect or establish any term, condition or covenant of this agreement or right of either party, the parties agree to bear their own attorneys' fees and costs.

**USE AGREEMENT BETWEEN CITY OF HIALEAH AND FLORIDA NATIONAL UNIVERSITY, INC.**

This agreement is made and entered into this 20th day of August, 2013, by and between the City of Hialeah (hereinafter referred to as "CITY"), a municipal corporation of the State of Florida having its principal place of business at 501 Palm Avenue, Hialeah, Florida, and Florida National University, Inc. (hereinafter referred to as "USER"), a Florida corporation having its principal place of business at 4425 West 20<sup>th</sup> Avenue, Hialeah, Florida 33012.

**CONDITIONS OF USE**

1. The CITY agrees to provide the gymnasium at Buck Dent Park at 2250 West 60<sup>th</sup> Street, Hialeah, Florida to the USER for their college basketball practices and games. The USER agrees to pay the CITY as follows: \$1,310.00 prior to September 30, 2013, \$970.00 prior to November 1, 2013, \$1,030 prior to December 1, 2013, \$1,260.00 prior to January 1, 2014, and \$1,110.00 prior to February 1, 2014. The total rental fee owed is \$5,680.00. (See Exhibit "1")
2. This agreement is effective from September 30, 2013 through February 28, 2014. Under no circumstances shall this agreement be renewed, amended, or extended except in a writing executed by both parties. The parties may agree to renew the terms of this agreement for a one-year period; provided, written notice of renewal is agreed to by both parties at least 30 days prior to the expiration of the agreement term.
3. The USER guarantees that no damage will be done to the facility.
4. The USER shall pay the CITY for the cost of any repair, rehabilitation, damage, correction, replacement or restoration of the facility or to defray any other unusual but reasonable expense borne by the CITY as a consequence of this agreement.
5. Either party hereto may terminate this agreement at any time by giving to the other party notice in writing at least 30 days prior to the intended termination date.

The USER acknowledges that the USER and its personnel are not employees or independent contractors of the CITY and that the CITY shall not be responsible for providing workers' compensation insurance for any of the USER's personnel. 8. Each party shall be responsible for its own attorney's fees and costs incurred as a result of any action or proceeding under this agreement. If either party brings any action or legal proceeding for damages for an alleged breach of any provision of this agreement or to enforce, protect or establish any term, condition or covenant of this agreement or right of either party, the parties agree to bear their own attorneys' fees and costs.






