The City Clerk of the City of Hialeah, Florida, will receive sealed bids for the project entitled: **“Well Site #11” Proposed 12 Inch Raw Water and 12 Inch Maintenance Line, until 11:00 a.m. on Thursday, February 9, 2012,** at the Hialeah City Hall, 501 Palm Avenue, Third Floor Council Chambers, Hialeah, Florida, at which time all bids will be publicly opened and read aloud.

Contract documents, including drawings, technical specifications and proposal forms may be obtained at a cost of \$150.00 non-refundable check from the Purchasing Department, located at City Hall, 501 Palm Avenue, Fourth Floor, Hialeah, Florida, by calling 305-883-5846, or by emailing Carlos Lopez at CLopez@hialeahfl.gov.

Bids shall be submitted in sealed envelopes and shall bear on the face, thereof, the bid number and the complete name and address of the bidder. Bids are to be based strictly upon contract documents and instructions herein with no deviations or alternates being considered at bid time, other than those specific requests on the proposal sheets.

EARLY FINISH INCENTIVE: For each day that the Contractor completes the Scope of Work before the date when the Contract Time provides for completion as specified in the Notice to Proceed, the Contractor shall receive a monetary incentive (\$ rate/day), up to a maximum of 30 days. The full amount of the monetary incentive to be determined and based on the amount of the successful bid. All time extension requests which are ultimately approved and accepted shall be automatically deducted from this 30-day bonus provision regardless of reason.


Bid bond will be required. The bid surety will be in the amount of 5% of the bid or you may submit a certified check or bank draft payable to the City of Hialeah. Should the contractor fail to submit the bid bond, the bid will automatically be forfeited. **If the contract amount exceeds \$ 200,000.00, Performance and Payment Bonds will be required and should be in the amount of the contract, and must be submitted prior to the Notice to Proceed.**

Minimum experience, manpower and bonding capacity requirements for a bidder will provided in the bid documents. Bidders must guarantee the bid price for a period of ninety (90) calendar days. Bidders shall abide by the requirements of the Miami-Dade County responsible / living wage ordinance and the Miami-Dade County Inspector General fee ordinance.

The City of Hialeah reserves the right to reject any and all bids, or to waive any informality in the bidding. Bids may be held by the City of Hialeah for a period not to exceed thirty (30) days from the date of opening for the purpose of reviewing the bids and investigating the qualifications of the bidders, prior to awarding of the contract.

The City of Hialeah reserves the right to accept or reject bids on each item separately or as a whole.
