The City Clerk of the City of Hialeah, Florida will receive bids for the project entitled **Roadway and Sidewalk Improvements of East 4th Avenue from Hialeah Drive to East 21st Street** until 11:00 A.M. **Tuesday, May 11th, 2010**, at the Hialeah City Hall, 501 Palm Avenue, Third Floor, Hialeah, Florida, at which time all bids will be publicly opened and read aloud.

Contract documents, drawings, technical specifications, may be obtained at the Purchasing Office, City Hall, 501 Palm Avenue, 4th Floor, Hialeah, Florida, or by calling 305-883-5846. A deposit of \$50.00 non-refundable per set of drawings and specifications is required with a limit of two (2) sets per contractor. The deposit must be in the form of a check payable to the City of Hialeah.

There will be no pre-bid meeting.

Bid and performance bonds will be required. A bid guarantee equivalent to five (5%) percent of the bid price must be submitted with the bid. The bid guarantee shall consist of a firm commitment such as bid bond, certified check or other negotiable instrument accompanying a bid as assurance that the bidder will, upon acceptance of his bid, execute such contractual documents as may be required within the time specified. Should the contractor fail to execute such contractual documents, the bid bond will automatically be forfeited to the City.

This project is funded in whole or in part by the Florida Department of Transportation. The award is subject to criteria and conditions established under the Davis-Bacon Act, as supplemented by 29 CFR Part 5; the Copeland (Anti-Kick Back) Act; the Contract Work Hours and Safety Standards Act as supplemented by 29 CFR Part 5 and all other applicable federal, state and local ordinances. The Contractor must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex or national origin.

FDOT PRE-QUALIFIED FOR ROADWAY

The City of Hialeah reserves the right to reject any and all bids including nonconforming, nonresponsive, unbalanced or conditional responses, or to waive any informality in the bidding. Bids may be held by the City of Hialeah for a period not to exceed thirty (30) days from the date of opening for the purpose of reviewing the bids and investigating the qualifications of the bidders, prior to awarding of the contract.
