



**CITY OF HIALEAH
NOTICE OF PUBLIC HEARING
PROPOSED AMENDMENT TO PRIOR CDBG PROGRAM YEARS
30 DAY COMMENT PERIOD**

The City of Hialeah is an entitlement recipient of federal funds from the U.S. Department of Housing and Urban Development Block Grant (CDBG). In order to receive these funds, the City must adopt a one-year Action Plan that is consistent with its 2015-2020 Consolidated Plan for Housing and Community Development Programs. The following amends the previously approved Action Plans for addition to the 2016 Action Plan.
