**PURPOSE:** To obtain public comments and input on housing and community development needs for the City of Hialeah U.S. HUD 2020-2024 Consolidated Plan and the 2020 Annual Action Plan, which covers the period from October 1, 2020 to September 30, 2021, for the HUD formula entitlement programs Community Development Block Grant (CDBG), HOME Investment Partnership (HOME) Program, and the Emergency Solutions Grant (ESG). The activities under these programs will be presented for final approval by the Mayor and City Council at the Special Virtual City Council meeting scheduled for August 11, 2020, at 7:00 PM.
