

**RESOLUTION NO. 2019-067**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA REAPPOINTING CHRISTOPHER ZACARIAS AS SPECIAL MASTER TO CONDUCT ADMINISTRATIVE HEARINGS ON CODE VIOLATIONS FOR THE CITY OF HIALEAH, FLORIDA, PURSUANT TO THE CITATION PROCEDURES SET FORTH IN CHAPTER 22, ARTICLE III, OF THE HIALEAH CODE, ASSUME ALL POWERS AUTHORIZED BY HIALEAH CODE § 22-186(k), AND SERVE A TERM COMMENCING ON JUNE 1, 2019 AND ENDING ON MAY 31, 2020, AT AN HOURLY RATE TO BE ESTABLISHED BY ADMINISTRATIVE ORDER OF THE MAYOR; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, pursuant to Hialeah, Fla., Ordinance 95-63 (Aug. 22, 1995), the City of Hialeah adopted citation or ticketing procedures for the prosecution of Code violations within the City; and

**WHEREAS**, pursuant to Hialeah Code §§ 22-151 through 153, the City Council shall vote to approve appointments for special masters to conduct administrative hearings and assume powers provided by Chapter 22, Article III, of the Hialeah Code; and

**WHEREAS**, pursuant to Hialeah Code § 22-151, the qualifications of an appointed special master involve an outstanding reputation for civic pride, interest, integrity, responsibility, and business or professional activity and the City finds that Christopher Zacarias meets these qualifications and should be appointed.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


**Section 1:** The foregoing recitations and facts of the preamble to this resolution are hereby adopted and incorporated by reference thereto as if fully set forth herein.

**Section 2:** The City of Hialeah hereby reappoints Christopher Zacarias as Special Master to conduct administrative hearings on Code violations for the City of Hialeah, Florida, pursuant to the citation procedures set forth in Chapter 22, Article III, of the Hialeah Code, assume all powers authorized by Hialeah Code § 22-186(k) and serve a

term commencing on June 1, 2019 and ending on May 31, 2020, at an hourly rate established by administrative order of the Mayor. This appointment is subject to removal, for cause or without cause, by resolution of the Hialeah City Council.


**Section 3:** This resolution shall become effective upon signature of the Mayor.




