

**RESOLUTION NO. 2019-142**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE EXPENDITURE OF FUNDS IN AN AMOUNT NOT TO EXCEED \$18,700.00 FROM THE LAW ENFORCEMENT TRUST FUND- FEDERAL, TO PURCHASE PROTECTIVE POLICE GEAR AGAINST HIGH-POWERED ASSAULT RIFLES FOR THE POLICE SWAT UNIT FROM SRT SUPPLY, INC.; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Hialeah Police Department SWAT unit is equipped with body armor that is set to expire; and

**WHEREAS**, keeping the City's law enforcement officers safe by supplying them with the necessary equipment to minimize the risk of serious injury or death is critical to in operating an effective police department; and

**WHEREAS**, the vendor's prices are competitive based on a cooperative contract administered by the State of Colorado to which the State of Florida is a participating entity (NASPO Valuepoint Master Agreement 2016-181; and

**WHEREAS**, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Trust Fund - Federal; and

**WHEREAS**, the Chief of Police has recommended adoption of this Resolution and has determined that the proposed expenditure complies with all applicable statutes;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


**Section 1:** The foregoing facts and recitations contained in the preamble to this ordinance are hereby adopted and incorporated by reference as if fully set forth herein.

**Section 2:** The City of Hialeah, Florida hereby authorizes the expenditure of funds from the Law Enforcement Trust Fund – Florida in an amount not to exceed


\$18,700.00 to pay for select body armor from SRT Supply, Inc. as reflected in the quote for order number 113294 attached as Exhibit 1.

**Section 3:** This resolution shall become effective when passed by the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.
