

RESOLUTION NO. 2020-041

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AUTHORIZING THE APPLICATION FOR, AND THE ACCEPTANCE OF, A GRANT FROM THE FEDERAL UNIVERSAL SERVICE FUND (e-RATE) FOR SCHOOLS AND LIBRARIES, FOR STATE FISCAL YEAR 2020-2021, FOR DISCOUNTS ON INTERNET AND TELECOMMUNICATION SERVICES WHEREBY THE GRANT PROVIDES FOR AN 80% DISCOUNT TO THE CITY OF HIALEAH'S PUBLIC LIBRARIES FOR INTERNET SERVICES; AND AUTHORIZING THE EXPENDITURE OF \$12,840.00 ANNUALLY FOR TWO YEARS, AND FURTHER AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO EXECUTE AND EXTEND THE INTERNET PROVIDER AGREEMENT FOR AN ADDITIONAL TWO YEAR TERM WITH COMCAST BUSINESS COMMUNICATIONS, LLC; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Hialeah finds it in its best interest to continue a program for discounted internet and telecommunications services for the Hialeah Public Libraries, including the JFK Memorial Library and the Curtiss, North, Walker, West and Wilde branches, funded in part by the Federal Universal Service Fund for Schools and Libraries; and

WHEREAS, the City of Hialeah, through its Library Department, has successfully participated in this program for 23 years; and

WHEREAS, the term pursuant to the present agreement between the City and Comcast Business Communications, LLC ends on May 10, 2020; and

WHEREAS, the City and Comcast Business Communications, LLC have the option to renew for a two year term as provided in paragraph 6 of the first amendment to the internet services agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The Mayor and the City Council of the City of Hialeah, Florida hereby authorize the application for, and the acceptance of, a grant from the Federal Universal Service Fund (e-rate) for schools and libraries, for State Fiscal Year 2020-2021, for discounts on internet and telecommunication services whereby the grant provides for an 80% discount to the City of Hialeah's Public Libraries for internet services.

Section 3: The Mayor and the City Council of the City of Hialeah, Florida hereby authorize the expenditure of \$12,840.00 annually for two years, and further authorize the Mayor and the City Clerk, as attesting witness, on behalf of the city, to execute and extend the internet provider agreement for an additional two year term with Comcast Business Communications, LLC; See Exhibit "A" attached.

Section 4: Effective Date.



SECOND AMENDMENT
To
Services Agreement No. FL-CMunro-050417-01

This Second Amendment ("Amendment"), made effective as of February 20, 2020 ("Effective Date") modifies and amends the Services Agreement No. FL-CMunro-050417-01 ("Agreement"), by and between Comcast Business Communications, LLC ("Company") and Hialeah Public Library System ("Customer"), individually referred to herein as "Party", and jointly referred to as "Parties". In the event of conflict between this Amendment and the Agreement, the terms and conditions of this Amendment shall take precedence in the interpretation of the explicit matter in question. Unless otherwise set forth herein, all capitalized terms set forth herein shall have the same meaning as set forth in the Agreement.

Whereas, Customer and Company have previously entered into the Agreement and whereby Company agreed to provide Customer the Services more particularly described therein;

Whereas, the Parties desire to amend the Agreement by this writing to reflect the amended or additional terms to which the Parties have agreed to;

Now, therefore, in consideration of the mutual covenants, promises, and consideration set forth in this Amendment, the Parties agree as follows:

1. At the request of the Customer, Comcast shall extend the term of the Agreement for an additional twenty-four (24) months at the MRC set forth in the Sales Order attached hereto .
2. This Amendment shall commence as of the Effective Date set forth herein.

IN WITNESS WHEREOF, the Parties hereto have executed this Amendment as of the day and year written below and the persons signing covenant and warrant that they are duly authorized to sign for and on behalf of the respective Parties. Except as otherwise modified by this Amendment, all other terms and conditions set forth in the Agreement, inclusive of any all preceding Amendments shall remain in full force and effect.
