The City is in receipt the 2020-M3 Campaign Treasurer's Report for the Campaign of Jose Moises Martinez. Please refer to the instructions for Campaign Treasurer's Report – Itemized Contributions – Form DS De 13, which requires a sequence number. Per the instructions “each detail line shall have a sequence number assigned to it. Sequence numbers are to be assigned within each reporting period and for each type of detail line.
