### **RESOLUTION NO.** 2020-075

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE IN AN AMOUNT NOT TO EXCEED \$14,999.85 FROM THE LAW ENFORCEMENT TRUST FUND-FEDERAL FOR THE PURCHASE EIGHT (8) ASSAULT OF CARRIERS, EIGHT (8) SIDE BALLISTIC PANELS, AND SIXTEEN (16) BALLISTIC LEVEL THREE RIFLE PLATES (BODY ARMOR) FROM SRT SUPPLY, LLC REQUESTING EXEMPTION AN COMPETIVE BIDDING BASED ON THE USE OF A COMPETITIVELY **GOVERNMENTAL** BID CONTRACT ADMINISTERED BY THE STATE OF COLORADO (NASPO MASTER AGREEMENT 2016-181), UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, law enforcement officers with the Hialeah Police Department need critical equipment such as body armors that provide personal protection and can save the life of a police officer on the field; and

WHEREAS, there is an increase use of high-powered assault rifles by persons engaged in criminal activity such as trafficking narcotics and drive-by shootings; and

WHEREAS, the Special Investigations Section of the Hialeah Police Department is presently not equipped with body armor that can withstand high powered assault shootings; and

WHEREAS, Hialeah Police Department seeks to purchase eight (8) assault plate carriers, eight (8) side ballistic panels, and sixteen (16) ballistic level three rifle plated (body armor) from SRT Supply, LLC; and

**WHEREAS**, the equipment will be utilized during execution of search warrants, execution of arrest warrants, and apprehension of subjects;

**WHEREAS**, SRT Supply, LLC is an active corporation in good standing in the state of Florida and offers a special pricing pursuant to a competitively bid governmental contract administered by the state of Colorado (NASPO master agreement 20160-181), hereinafter attached as "Exhibit 1," and

**WHEREAS**, the Hialeah Police Department is requesting an exemption from competitive bidding based on the use of a competitively bid governmental contract administered by the state of Colorado (NASPO master agreement 20160-181); and

**WHEREAS**, funding for this project will be from account 127.1000.521.640 Law Enforcement Trust Fund-*Federal*; and

**WHEREAS**, Section 932.7055, Fla. Stat. (2018), the Florida Contraband and Forfeiture Act, authorizes the expenditure of Law Enforcement Trust Funds-*Federal* for this purpose and the funds are available in the Law Enforcement Trust Fund-*Federal* account for the Police Department; and

WHEREAS, the Chief of Police of the Hialeah Police Department has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, and all applicable rules, regulations and guidelines governing the expenditure of Law Enforcement Trust Fund-Federal; and

WHEREAS, the City finds the expenditure is in the public interest;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

<u>Section 1:</u> The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby approves the expenditure of an amount not exceeding \$14,999.85 eight (8) assault plate carriers, eight (8) side ballistic panels, and sixteen (16) ballistic level three rifle plated (body armor) from SRT Supply, LLC from the Law Enforcement Trust Fund-Federal and providing an exemption from competitive bidding based on the use of a competitively bid governmental contract administered by the state of Colorado (Naspo Master Agreement 2016-181), upon such costs having been approved by the Chief of Police of the Hialeah Police Department having specifications and pursuant to the terms and conditions as set forth in "Exhibit 1."

Section 3: This resolution shall become effective when passed by the City Council and signed by the Mayor.



Dear Mayor Hernandez and Council Members:

The Charter of Hialeah states that contracts in amounts greater than \$15,000.00 shall be awarded on the basis of specifications and formal sealed bids. The Council may award a contract to the lowest responsible and responsive bidder, or it may reject all bids and re-advertise; or it may waive competitive bidding when it finds it to be the best interest of the City.

One of the Hialeah Police Department's mission is to respond to incidents with armed subjects. The current trend, both nationally and locally is the use of high powered assault rifles in various crimes and drive by shootings. Currently the Special Investigations Section is not equipped with body armor that can withstand high powered assault shootings. The Police Department is requesting body armor that can protect officers from the high powered assault rifles. The Special Investigations Section will utilize these body armors for take downs and search warrants.

The Hialeah Police Department is requesting an exemption from competitive bidding based on the use of a competitively bid governmental contract administered by the State of Colorado (NASPO master agreement 2016-181). The body armor shall be purchased from SRT Supply, 1523 Chaffee Road S. Unit 12 Jacksonville, Fl 32221. SRT Supply is an active corporation and in good standing in the state of Florida.
