Notice is hereby given that on the date and time indicated above, the City Council will meet through the Zoom virtual meeting platform to hear a presentation by Ines Beecher, Director of Office of Budget Management, to review anticipated revenues and expenses in preparation for the adoption of the upcoming budget for fiscal year 2021.

As a result of the public health emergency caused by Coronavirus (COVID-19), the restrictions on person-to-person contact, social distancing guidelines, and stay-at-home orders to stop the spread of COVID-19 promulgated by national, state, local authorities and as authorized by Governor Ronald DeSantis's Executive Order 20-69 (March 20, 2020), this Virtual Public Meeting will be held utilizing communications media technology, including video and telephonic conferencing. Any person wishing to appeal any decision made by the City Council with respect to any matter considered at this meeting, will need a record of the proceedings and, for such purposes, may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
