

**RESOLUTION NO. 2020-101**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE IN AN AMOUNT NOT TO EXCEED \$117,590.00 FROM THE LAW ENFORCEMENT TRUST FUND-*STATE* FOR THE PURCHASE OF THREE HUNDRED (300) AVON PROTECTION SYSTEMS FULL FACE RESPIRATORS AND TWO HUNDRED (200) FILTERS FROM W.W. GRAINGER INC., LOWEST QUOTED VENDOR, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE, AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, it is the practice of the Hialeah Police Department to respond quickly and effectively to any situation or emergency event in the most professional manner possible to protect life and property; and

**WHEREAS**, Avon Protection Systems full face respirators and filters will be utilized by all law enforcement officers in the Hialeah Police Department to minimize respiratory exposure risks while on duty; and

**WHEREAS**, Avon Protection Systems full face respirators will provide maximum operations flexibility to counter multiple threat scenarios, including chemical, biological, nuclear and radiological agents, toxic chemicals, and toxic industrial materials; and

**WHEREAS**, W.W. Grainger Inc. is an active corporation in good standing in the state of Florida; and

**WHEREAS**, W.W. Grainger Inc. is the lowest quoted vendor for the Avon Protection Systems full face respirators and filters; and

**WHEREAS**, funding for this project will be from account 105.1000.521.640 Law Enforcement Trust Fund-*State*; and

**WHEREAS**, Section 932.7055, Fla. Stat. (2018), the Florida Contraband and Forfeiture Act, authorizes the expenditure of Law Enforcement Trust Funds-*State* for this purpose and the funds are available in the Law Enforcement Trust Fund-*State* account for the Police Department; and

**WHEREAS**, the Chief of Police of the Hialeah Police Department has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, and all applicable rules, regulations and guidelines governing the expenditure of Law Enforcement Trust Fund-*State*; and

**WHEREAS**, the City finds the expenditure is in the public interest;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

**Section 2:** The City of Hialeah, Florida hereby approves the expenditure of an amount not exceeding \$117,590.00 for the purchase of three hundred (300) Avon Protection Systems full face respirators and two hundred (200) filters itemized in "Exhibit 1" (attached hereto) from W.W. Grainger Inc., lowest quoted vendor, from the Law Enforcement Trust Fund-State upon such costs having been approved by the Chief of Police of the Hialeah Police Department having specifications and pursuant to the terms and conditions as set forth in "Exhibit 1."


**Section 3:** This resolution shall become effective when passed by the City Council and signed by the Mayor.



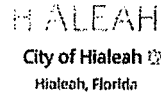

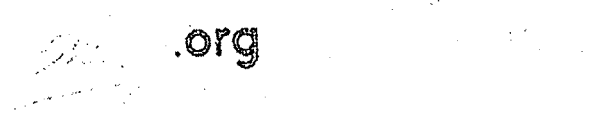
