

RESOLUTION NO. 2020-136

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE IN AN AMOUNT NOT TO EXCEED \$40,410.00 FROM THE LAW ENFORCEMENT TRUST FUND-*STATE* FOR THE PURCHASE OF SIX (6) S.W.O.R.D. DEPLOYABLE WEAPONS KIT AND S.W.O.R.D. INTERNATIONAL SEMI-AUTO FAMILIARIZATION AGENCY TRAINING COURSE FROM LOU'S POLICE DISTRIBUTOR, LOWEST QUOTED VENDOR, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, it is the practice of the Hialeah Police Department to respond quickly and effectively to any situation, including hostage barricades and active shooter situations, in the most professional manner possible to protect life and property; and

WHEREAS, Special Weapons and Tactics Team (SWAT) in the Hialeah Police Department is a law enforcement unit which uses specialized or military equipment and tactics; and

WHEREAS, S.W.O.R.D. MK17 weapon is an accurate and reliable type of weapon that helps reduce liability with higher probability of hitting the intended target; and

WHEREAS, SWAT operators in the Hialeah Police Department are in need of S.W.O.R.D. Deployable Weapons Kit and familiarization training course which includes MK17 weapons and training to achieve tactical excellence; and

WHEREAS, the Hialeah Police Department needs the tools such as MK17 weapons that are critical for the protection of life and property and for the preservation of the public peace, safety, health, welfare, and for the continuity of efficient government operations; and

WHEREAS, Lou's Police Distributor is an active corporation in good standing in the state of Florida and is the lowest quoted vendor; and

WHEREAS, funding for this project will be from account 105.1000.521.640 Law Enforcement Trust Fund-*State*; and

WHEREAS, Section 932.7055, Fla. Stat. (2018), the Florida Contraband and Forfeiture Act, authorizes the expenditure of Law Enforcement Trust Funds-*State* for this purpose and the funds are available in the Law Enforcement Trust Fund-*State* account for the Police Department; and

WHEREAS, the Chief of Police of the Hialeah Police Department has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, and all applicable rules, regulations and guidelines governing the expenditure of Law Enforcement Trust Fund-*State*; and

WHEREAS, the City finds the expenditure is in the public interest;


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby approves the expenditure of an amount not exceeding \$40,410 for six (6) S.W.O.R.D. deployable weapons kits and familiarization agency training course itemized in "Exhibit 1" (attached hereto) from Lou's Police Distributor, lowest quoted vendor, from the Law Enforcement Trust Fund-*State*, upon such costs having been approved by the Chief of Police of the Hialeah Police Department having specifications and pursuant to the terms and conditions as set forth in "Exhibit 1."

Section 3: This resolution shall become effective when passed by the City Council and signed by the Mayor.
