

**RESOLUTION NO 2020-181**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE IN AN AMOUNT NOT TO EXCEED \$55,425.00 FROM THE LAW ENFORCEMENT TRUST FUND-*STATE* FOR THE PURCHASE OF SIXTY (60) GLOCK34 GEN5 PISTOLS, SIXTY (60) AMERIGLO SIGHTS, SIXTY (60) TRIJICON OPTICS AND SIXTY (60) SAFARILAND HOLSTERS FROM LOU'S POLICE DISTRIBUTORS, INC., LOWEST QUOTED VENDOR, AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Hialeah Police Department is in need to replace thirty (30) Glock pistols via a trade-in and add thirty (30) more Glock pistols; and

**WHEREAS**, the Hialeah Police Department SWAT and K9 unit are in need of Glock pistols to continue to serve and protect; and

**WHEREAS**, the new Glock pistol provides sighting with a dot which is faster than using traditional iron sights providing for a simpler, faster, and more accurate shot; and

**WHEREAS**, the Hialeah Police Department seeks to purchase sixty (60) Glock34 Gen5 Pistols, sixty (60) Ameriglo sights, sixty (60) Trijicon Optic and sixty (60) Safariland holsters from Lou's Police Distributors, Inc., and

**WHEREAS**, the Hialeah Police Department will be trading in thirty (30) Glocks of a total value of \$9,900; and

**WHEREAS**, Lou's Police Distributors is an active corporation in good standing in the state of Florida; and

**WHEREAS**, funding for this project will be from account 105.1000.521.640 Law Enforcement Trust Fund-*State*; and

**WHEREAS**, Section 932.7055, Fla. Stat. (2018), the Florida Contraband and Forfeiture Act, authorizes the expenditure of Law Enforcement Trust Funds-*State* for this purpose and the funds are available in the Law Enforcement Trust Fund-*State* account for the Police Department; and

**WHEREAS**, the Chief of Police of the Hialeah Police Department has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, and all applicable rules, regulations and guidelines governing the expenditure of Law Enforcement Trust Fund-*State*; and

**WHEREAS**, the City finds the expenditure is in the public interest;


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

**Section 2:** The City of Hialeah, Florida hereby approves the expenditure of an amount not exceeding \$55,425.00 from the Law Enforcement Trust Fund-*State* for the purchase of sixty (60) Glock34 Gen5 Pistols, sixty (60) Ameriglo sights, sixty (60) Trijicon Optics and sixty (60) Safariland holsters from Lou’s Police Distributors, Inc., lowest quoted vendor, having specifications and pursuant to the terms and conditions as set forth in “Exhibit 1.”

**Section 3:** This resolution shall become effective when approved by majority vote of the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor’s signature is withheld or if the City Council overrides the Mayor’s veto.



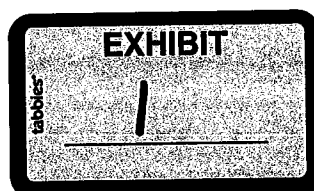

Dear Mayor Hernandez and Council Members:

The Charter of Hialeah states that contracts in amounts greater than \$15,000.00 shall be awarded on the basis of specifications and formal sealed bids. The Council may award a contract to the lowest responsible and responsive bidder, or it may reject all bids and re-advertise; or it may waive competitive bidding when it finds it to be the best interest of the City.

The Hialeah Police Department will be replacing thirty Glock pistols via a trade-in and adding thirty more to its inventory. The Glock pistols will be utilized by our SWAT and K9 unit. The new Glock pistol was tested and approved by our personnel. The new pistol provides sighting with a dot which is faster than using traditional iron sights providing for a simpler, faster, and more accurate shot.

Funding for the purchase of the Glock pistols and accessories is provided by the Law Enforcement Trust Fund (LETF). Quotes were obtained via the govquote platform (web based marketplace). 357 companies were notified through the platform and four provided quotes. Lou's Police Distributor is the lowest quoted vendor. Lou's Police Distributor is an active corporation and is in good standing in the State of Florida.
