

RESOLUTION NO. 2020-179

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO ENTER INTO A PROFESSIONAL SERVICES AGREEMENT WITH DOJO OF EXCEPTIONAL WELLNESS, INC. TO PROVIDE THE PARTICIPANTS OF THE CITY'S SPECIAL POPULATIONS THERAPEUTICS ENRICHMENT PROGRAM WITH KARATE EXERCISE CLASSES SPECIFICALLY DESIGNED FOR ADULTS WITH SPECIAL NEEDS, FOR A TERM COMMENCING ON OCTOBER 9, 2020 AND ENDING ON SEPTEMBER 17, 2021, IN AN AMOUNT NOT TO EXCEED \$3,000.00, IN SUBSTANTIAL CONFORMITY WITH THE AGREEMENT ATTACHED HERETO AND MADE A PART HEREOF AS EXHIBIT "1"; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Hialeah is continuously searching for new ways to support, expand and improve its educational programs and services to the community;

WHEREAS, pursuant to Hialeah, Fla., Resolution 2020-108 (August 25, 2020), as amended by Hialeah, Fla., Resolution 2020-126 (October 6, 2020), the City Council authorized the Mayor or his designee on behalf of the City to submit to the United States Department of Housing and Urban Development ("US HUD") the City's Action Plan, with the corresponding budgets for Fiscal Year 2020-2021, and proposed allocations for selected programs for CDBG, HOME, and ESG awarded sub-recipients, and to execute any and all agreements, certifications and assurances in furtherance of the programs in the Action Plan in accordance with US HUD regulations;

WHEREAS, the City having investigated the qualifications of DOJO of Exceptional Wellness, Inc. (hereafter referred as to "Provider") to perform all the work necessary to fully carry out the scope of services contemplated in the Professional Services Agreement, found the Provider to be qualified and competent; and

WHEREAS, the City agrees to enter into this Professional Services Agreement with the Provider and the Provider agrees to accept the engagement under the terms and conditions included in the Professional Services Agreement attached hereto in substantial form, and made a part hereof as Exhibit "1".


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby incorporated and adopted by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby authorizes the Mayor and the City Clerk, as attesting witness, on behalf of the City, to enter into a Professional Services Agreement with DOJO of Exceptional Wellness, Inc. to provide the participants of the City's Special Populations Therapeutics Enrichment Program with karate exercise classes specifically designed for adults with special needs, for a term commencing on October 9, 2020 and ending on September 17, 2021, in an amount not to exceed \$3,000.00, in substantial conformity with the Agreement attached hereto and made a part hereof as Exhibit "1". All actions taken to date by officers of the City in furtherance of this Agreement are hereby approved, confirmed, and ratified.






