

RESOLUTION NO. 2021-007

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE IN AN AMOUNT NOT TO EXCEED \$172,984.00 FROM THE LAW ENFORCEMENT TRUST FUND-*STATE* FOR THE PURCHASE OF SEVEN (7) CHEVROLET SILVERADO MOTOR VEHICLES PURSUANT TO A COMPETITIVE BID UTILIZING FLORIDA SHERIFF ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES BID FSA20-VEL28.0 AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, motor vehicles are a necessary means of transportation for law enforcement officers of the Hialeah Police Department when performing duties in official capacity; and

WHEREAS, Hialeah Police Department regularly analyzes its fleet composition to assess the need for replacement motor vehicles while remaining cost effective and within budget; and

WHEREAS, motor vehicles are needed to replace an aging fleet of vehicles being utilized by Traffic Homicide Investigators (hereinafter referred to as “THI”) of the Hialeah Police Department; and

WHEREAS, THI respond to traffic accidents that occur in the City of Hialeah involving serious bodily injuries and/or death and reconstruct the manner in which a crash occurred in order to show whether any person involved is civilly or criminally liable for the personal injury or death of another and conduct subsequent follow up; and

WHEREAS, THI currently has three 2009 Ford F150’s motor vehicles and four 2012 Ford F150’s with an average mileage of 121,214; and

WHEREAS, new motor vehicles will decrease the repair, maintenance, and fuel costs of aging fleet; and

WHEREAS, Auto Nation Chevrolet has provided a competitive bid of \$24,712 per 2021 Chevrolet Silverado Double Cab motor vehicle utilizing Florida Sheriff Association and Florida Association of Counties, bid FSA20-VEL28.0; and

WHEREAS, Auto Nation Chevrolet is an active corporation in good standing in the State of Florida; and

WHEREAS, the total cost of seven (7) motor vehicles will not exceed \$172,984.00 and it is to be drawn against account 105.1000.521645 Capital Outlay – Vehicle; and

WHEREAS, funding for this project will be from account #105.1000.521.645 Law Enforcement Trust Fund-*State*; and

WHEREAS, Section 932.7055, Fla. Stat. (2018), the Florida Contraband and Forfeiture Act, authorizes the expenditure of Law Enforcement Trust Funds for this purpose and the funds are available in the Law Enforcement Trust Fund-*State* account for the Police Department; and

WHEREAS, the Chief of Police of the City of Hialeah Police Department has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, and all applicable rules, regulations and guidelines governing the expenditure of Law Enforcement Trust Fund-*State*; and

WHEREAS, the City finds the expenditure is in the public interest;


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby approves the expenditure of an amount not exceeding \$172,984.00 from the Law Enforcement Trust Fund-*State* for the purchase of seven (7) Chevrolet Silverado motor vehicles from Auto Nation Chevrolet, a corporation pursuant to a competitive bid having specifications and pursuant to the terms and conditions as set forth in "Exhibit 1."

Section 3: This resolution shall become effective when approved by majority vote of the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.


