Dear Ms. Castellanos,

Your 2021-M3, Campaign Treasurer's Report was due on April 12, 2021. As of today's date, the Office of the City Clerk has not received your report. On December 17, 2020, you were provided with the City of Hialeah 2021 Election Important Dates and Deadlines, which includes the due dates of all Campaign Treasurer's Reports.

Please note that in any reporting period in which there has been no activity in your campaign account, meaning no funds expended or received, the filing of the required report is waived. However, the City Clerk must be notified in writing *on the prescribed reporting date* that no report is being filed.

Pursuant to § 106.07 (8)(b) of the Florida Statutes, I must impose a fine of \$50.00 per day for each day late, and thereafter, \$500.00 per day, not to exceed twenty-five (25) percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report.
