

RESOLUTION NO. 2021-090

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE IN AN AMOUNT NOT TO EXCEED \$24,495.00 FROM THE LAW ENFORCEMENT TRUST FUND-STATE FOR THE PURCHASE OF TWO (2) UNMANNED AERIAL VEHICLE (UAV) BRINC LEMUR DRONE S KITS, TWO (2) BRINC LEMUR DRONE ACCESSORY KITS AND A BRINC THREE (3) DAY TRAINING COURSE FROM ENTERPRISE UAS, LLC D/B/A DSLRPROS, THE LOWEST QUOTED VENDOR, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Hialeah Police Department is developing a unmanned aerial system (UAS) program to help provide effective public safety and law enforcement operations for the protection of our City and residents; and

WHEREAS, a unmanned aerial vehicle (UAV), commonly referred to as a drone, will be utilized to enhance the efficiency and safety of law enforcement activities by the Hialeah Police Department and combat crime;

WHEREAS, a drone is defined in Florida Statutes Section 934.50 as a powered aerial vehicle that (1) does not carry a human operator; (2) uses aerodynamic forces to provide vehicle lift; (3) can fly autonomously or be piloted remotely; (4) can be expendable or recoverable; (5) can be expendable or recoverable; and (6) can carry a lethal or nonlethal payload; and

WHEREAS, a UAV offers a safe, effective and affordable option for enhancing a wide variety of law enforcement operations such as searching for missing and endangered persons; providing real time situational awareness during critical incidents; supporting officers servicing warrants; fugitive location and apprehension; crime scene reconstruction and imagery; SWAT operations; tactical operations; assistance with disaster recovery; crowd monitoring and safety; investigating armed and dangerous subjects; and observation of hazardous materials; and

WHEREAS, in the past, the City has been impacted by catastrophic events such as hurricanes. If such a catastrophic event were to impact the City in the future, a UAV will provide real time information about how an event is unfolding and provide a safe way for members of the Hialeah Police Department to aid when there is imminent danger to life or serious damage to property; and

WHEREAS, UAV shall be deployed and used only to support official law enforcement and public safety missions of the Hialeah Police Department after requisite training is completed prior to UAV utilization; and

WHEREAS, the Hialeah Police Department is in the process of creating policy for the UAS program so that the right to privacy of City residents remains well protected and operating members comply with state and federal law and applicable Federal Aviation Administration (FAA) regulations; and

WHEREAS, Enterprise UAS, LLC, D/B/A DSLRPros, is the lowest quoted vendor for purchase of two UAVs and it is an active corporation in good standing in the State of California; and

WHEREAS, Enterprise UAS, LLC, D/B/A DSLRPros has provided a quote in an amount not to exceed \$24,495.00 for (2) UAV Brinc Lemur Drone S Kits quoted at a price of \$8,999.00 each, (2) Brinc Lemur Drone Accessory Kits quoted at a price of \$1,999.00 each and a Brinc three (3) day training course quoted at a price of \$2,499.00; and

WHEREAS, funding for this project will be from account #105.1000.521.640 Law Enforcement Trust Fund-*State*; and

WHEREAS, Florida Statutes Section 932.7055, the Florida Contraband and Forfeiture Act, authorizes the expenditure of Law Enforcement Trust Funds for this purpose and the funds are available in the Law Enforcement Trust Fund-*State* account for the Police Department; and

WHEREAS, the Chief of Police of the City of Hialeah Police Department has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, and all applicable rules, regulations and guidelines governing the expenditure of Law Enforcement Trust Fund-*State*; and

WHEREAS, the City finds the expenditure is in the public interest;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.


Section 2: The City of Hialeah, Florida hereby approves the expenditure of an amount not exceeding \$24,495.00 from the Law Enforcement Trust Fund-*State* for the purchase of (2) UAV Brinc Lemur Drone S Kits, (2) Brinc Lemur Drone Accessory Kits, and a Brinc three (3) day training course from Enterprise UAS, LLC, D/B/A DSLRPros, an active corporation in the State of California, lowest quoted vendor, and pursuant to the terms and conditions as set forth in "Exhibit 1."
