RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE MAYOR OR HIS DESIGNEE ON BEHALF OF THE CITY OF HIALEAH, FLORIDA, TO SUBMIT TO THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) THE ACTION PLAN BUDGETS FOR PROGRAM YEAR 21, COMMENCING ON OCTOBER 1, 2021 AND ENDING ON SEPTEMBER 30, 2022, A COPY OF WHICH IS ATTACHED HEREAFTER AS EXHIBIT A, WHICH SHALL INCLUDE THE ALLOCATIONS AND SELECTED PROGRAMS FOR CDBG, HOME, ESG; AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE ANY AND ALL AGREEMENTS, AMENDMENTS, CERTIFICATIONS AND ASSURANCES IN FURTHERANCE OF THE PROGRAMS IN THE ACTION PLAN IN ACCORDANCE WITH THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT REGULATIONS UPON THE CONCLUSION OF THE MANDATORY PUBLIC COMMENT PERIOD; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, in order for the City to receive federal funds for the next fiscal year for the HOME Investment Partnerships (HOME), the Community Development Block Grant (CDBG) and the Emergency Solutions Grant (ESG) programs, the City is required to submit an Action Plan which describes the activities to be undertaken for Program Year 2021 (October 1, 2021 to September 30, 2022).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby incorporated and adopted by reference as if fully set forth herein.

**Section 2:** The Mayor or his designee is hereby authorized on behalf of the City of Hialeah to submit the City of Hialeah Action Plan for Program Year 2021 including amendments, reprogramming of funds and revisions thereto, to the United States Department of Housing and Urban Development upon the conclusion of the mandatory public comment period, a copy which is attached as Exhibit A.

**Section 3:** The Mayor or his designee is further authorized to execute any and all agreements, certifications and assurances in furtherance of the programs in the Action Plan in accordance with United States Department of Housing and Urban Development regulations.






