

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE TOTALING AN AMOUNT NOT TO EXCEED \$18,387.52 FROM THE LAW ENFORCEMENT TRUST FUND - *STATE*, TO PURCHASE AND INSTALL A CCTV SECURITY SYSTEM AT THE DISTRICT 4 POLICE SUBSTATION AND IN ITS SURROUNDING VICINITY FROM COMMUNICATION & NETWORK SOLUTION, INC., AND WAIVING COMPETITIVE BIDDING AS IT IS ADVANTAGEOUS TO THE CITY, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE.

WHEREAS, the Hialeah Police Department desires to purchase and install a CCTV system at the District 4 police substation and in its surrounding vicinity, as a crime prevention tool and in an effort to continue ensuring safe neighborhoods, and

WHEREAS, Surveillance cameras serve as a deterrent and/or assist police in apprehending offenders after the crime has been committed and are an important component in the crime prevention and reduction strategies employed throughout the District and the Hialeah Police Department as a whole; and

WHEREAS, Communication & Network Solution, Inc. is the only vendor compliant with the Florida Department of Law Enforcement Criminal Justice Information Services (CJIS) which regulated the law enforcement sharing of criminal justice information; and

WHEREAS, the Hialeah Police Department requests to waive competitive bidding as it is advantageous to the City to utilize Communication & Network Solution, Inc. as they are the sole source that can provide services compliant with the Florida Department of Law Enforcement Criminal Justice Information Services agency requirements; and


WHEREAS, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Trust Fund - *State*; and

WHEREAS, the Chief of Police has recommended adoption of this resolution and determined that the proposed expenditure complies with Florida Statutes.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


Section 1. The Mayor and the City Council of the City of Hialeah, Florida, approve the expenditure of an amount not to exceed \$18,357.52 from the Law Enforcement Trust Fund – *State*, to purchase and install a CCTV security system for the District 4 police substation and in its surrounding vicinity, from Communication & Network Solution, Inc., and waiving competitive bidding as it advantageous to the City, upon such costs having been approved by the Chief of Police.


