

**RESOLUTION NO. 2019-045**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE TRANSFER OF UNENCUMBERED APPROPRIATION BALANCE OR A PORTION THEREOF BETWEEN CLASSIFICATIONS OF EXPENDITURES WITHIN AN OFFICE OR DEPARTMENT WITHIN THE GENERAL FUND; AND WITHIN THE SPECIAL REVENUE FUNDS, IN PARTICULAR, STREETS FUND, COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUND, E-911 NON WIRELESS FUND, FIRE PREVENTION FUND, FIRE RESCUE FUND, HOME INVESTMENT PARTNERSHIP FUND, PARK GRANT & IMPACT FEES FUND, CITT SURTAX-TRANSPORTATION FUND, POLICE GRANT FUND, CITT SURTAX HIALEAH CIRCULATOR FUND, 21<sup>ST</sup> CENTURY GRANT-ACADEMIC ACHIEVERS FUND, 21<sup>ST</sup> CENTURY STEAM AHEAD FUND, ECS AND LIBRARY GRANTS FUND, AND BUILDING DIVISION FUND; AND WITHIN THE CAPITAL FUNDS IN PARTICULAR, NW 102 AVENUE FUND AND WEST 76 STREET FUND; AND WITHIN THE PUBLIC WORKS FUNDS IN PARTICULAR, WATER & SEWER FUND AS SUMMARIZED AND ITEMIZED IN THE SCHEDULE ATTACHED AS EXHIBIT "A" AND MADE A PART HEREOF.

**WHEREAS**, the City Administration, by and through its Office of Management and Budget, based on actual experience during the first six months of Fiscal Year 2018-2019, requests that certain line item adjustments be approved by the City of Hialeah with the understanding the net effect of all adjustments will not increase or decrease the budgets of the General Fund, designated Special Revenue Funds, designated Capital Funds and designated Enterprise Fund of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The City of Hialeah, Florida, hereby authorizes the transfer of unencumbered appropriation balances or a portion thereof between classifications of expenditures within one office or department within the General Fund; and in particular, within


the Special Revenue Funds, in particular, Streets Fund, Community Development Block Grant (CDBG) Fund, E-911 Non Wireless Fund, Fire Prevention Fund, Fire Rescue Fund, Home Investment Partnership Program Fund, Park Grant & Impact Fees Fund, CITT Surtax Transportation Fund, Police Grant Fund, CITT Surtax Hialeah Circulator Fund, 21<sup>st</sup> Century-Academic Achievers Fund, 21<sup>st</sup> Century STEAM Ahead Fund, ECS & Library Grants Fund and Building Division Fund; within the Capital Funds, in particular, the NW 102 Avenue Fund, and West 76 Street Fund; and within the Public Works Funds, in particular, Water & Sewer Fund as summarized and itemized in the schedule attached as exhibit "A," which is attached and made a part hereof.

**Section 2:** This resolution shall become effective when passed by the City Council of the City of Hialeah, Florida and signed by the Mayor of the City of Hialeah, Florida or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.




