

**RESOLUTION NO. 2022-025**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING THE STREET NAMING AT EAST PALM COURT FROM EAST 34 STREET TO EAST 35 STREET "RENE LEOPOLDO RAMOS WAY", WITH THE COST OF SIGNAGE TO BE PAID BY THE CITY, IN HIS HONOR, AS A VIETNAM VETERAN AND ROLE MODEL IN THE CITY OF HIALEAH.

**WHEREAS**, the street naming at East Palm Court from East 34 Street to East 35 Street, Hialeah, Florida as "Rene Leopoldo Ramos Way" is in Honor of Rene Leopoldo Ramos, a Vietnam Veteran and role model in the City of Hialeah; and

**WHEREAS**, Mr. Ramos always eager to help people was a Boy Scout in Cuba and also an altar boy; and

**WHEREAS**, He served in the Vietnam War in the battle of Hamburger Hill and was wounded; for his bravery, he received the Purple Heart; and

**WHEREAS**, He was also awarded with the Vietnam Service Medal, Vietnam Campaign Medal, Infantryman Badge, Marksmanship Badge-Rifle and the National Defense Service Medal; and

**WHEREAS**, for 35 years he worked in the US Postal Service; and

**WHEREAS**, for 7 years he worked for the Women, Infants and Children (WIC); and

**WHEREAS**, in recognition of Mr. Ramos and his contributions to the community, this Board would like to urge the City of Hialeah to designate that portion of East Palm Court from East 34 Street to East 35 Street as "Rene Leopoldo Ramos Way" with the cost of signage to be paid by the City, in his honor as a veteran and role mode in the City of Hialeah; and

**WHEREAS**, East Palm Court from East 34 Street to East 35 Street is a city-maintained street located in the City of Hialeah; and



**Section 1.** The City Council designates that portion of East Palm Court from East 34 Street to East 35 Street as “Rene Leopoldo Ramos Way”, with the cost of signage to be paid by the City, in his honor, as a veteran and role model in the City of Hialeah.

**Section 2.** The City Clerk is directed to send a copy of this Resolution to the Mayor of Miami-Dade County and the Miami-Dade County Board of County Commissioners.


