RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AWARING BID NO. 2013/14-0240-00-014 TO THE LOWEST RESPONSIVE BID FROM A RESPONSIBLE COMPANY, METROPOLITAN LIFE INSURANCE COMPANY, FOR BASIC LIFE INSURANCE AND ACCIDENTAL DEATH AND DISMEMBERMENT INSURANCE COVERAGE FOR CITY EMPLOYEES AND RETIREES FOR A TERM OF 3 YEARS AT A RATE NOT TO EXCEED \$0.385 PER \$1,000 COVERAGE FOR LIFE INSURANCE AND \$0.028 PER \$1,000 COVERAGE FOR ACCIDENTAL DEATH AND DISMEMBERMENT INSURANCE WITH DECREASED RATES FOR ADDITIONAL MANAGEMENT AND ADDITIONAL SWORN POLICE LIFE INSURANCE PAID BY THE EMPLOYEE AND RETIREE AND AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO NEGOTIATE AND ENTER INTO AN AGREEMENT, IN A FORM ACCEPTABLE TO THE CITY ATTORNEY.

WHEREAS, on April 29, 2014, the City Clerk opened sealed bids submitted by Minnesota Life Insurance Company, Metropolitan Life Insurance Company, and Symetra Life Insurance Company to a duly advertised Bid No. 2013/14-0240-00-014 for rates for basic life insurance, accidental death and dismemberment insurance, additional management life insurance, additional life insurance for sworn police officers; and

WHEREAS, the City of Hialeah finds that it is in the best interest of the City to award the bid to Metropolitan Life Insurance Company after the City reviewed the bids and found the bid to be the lowest responsive bid from a responsible company.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby awards Bid No. 2013/14-0240-00-014 to the lowest responsive bid from a responsible company, Metropolitan Life Insurance Company, for Basic Life Insurance and Accidental Death and Dismemberment Insurance coverage for City employees and retirees for a term of 3 years at a rate not to exceed \$0.385 per \$1,000 coverage for Basic Life Insurance and \$0.028 per \$1,000 coverage for Accidental Death and Dismemberment Insurance with decreased rates for additional management and additional sworn police life insurance paid by the employee and retiree

Section 3: The City of Hialeah, Florida further authorizes the Mayor and the City Clerk, as attesting witness, on behalf of the City, to negotiate and enter into an agreement in a form acceptable to the City Attorney.






