

RESOLUTION NO. 2022-057

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING ALL DEPOSITORIES OF PUBLIC FUNDS OF THE CITY OF HIALEAH, FLORIDA, TO HONOR ANY CHECKS, CLAIMS, WARRANTS OR VOUCHERS THAT BEAR THE SIGNATURE OF ESTEBAN BOVO, JR., AS MAYOR, OR CARL ZOGBY, AS COUNCIL PRESIDENT, WHEN COUNTERSIGNED BY RUTH RUBI, AS CITY TREASURER, OR JORGE BLANCO, AS FINANCE DIRECTOR, PURSUANT TO HIALEAH CHARTER § 3.11(a) AND (b); REPEALING ALL RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING FOR A SAVINGS CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Hialeah Charter § 3.11(a) and (b), for checks, claims, warrants, or vouchers to be honored, they must bear the signature of the Mayor or the Hialeah City Council President, and the City Treasurer or Finance Director; and

WHEREAS, the Charter also requires the adoption a new resolution whenever there is a change in officeholders.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: All depositories of public funds of the City of Hialeah, Florida shall honor all checks, claims, warrants or vouchers that bear the signature of Esteban Bovo, Jr., as Mayor, or Carl Zogby, as President of the Hialeah City Council, when countersigned by Ruth Rubi, as City Treasurer, or Jorge Blanco, as Finance Director, pursuant to Hialeah Charter § 3.11(a) and (b).

Section 2: **Repeal of Resolutions in Conflict.** All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.


Section 3: **Savings Clause.** Notwithstanding the repeal or rescission of any resolution in conflict herewith, all acts taken pursuant to the authority of such prior existing resolutions shall be deemed and taken as lawful actions of the officeholders and

all rights, obligations, or liabilities contracted or incurred by such officeholders on behalf of the city shall continue of the same force and effect as though such act had not been repealed. All actions taken to date by officers and employees named herein in connection with the signing of any check, payment of any claim, warrant or voucher on behalf of the city are hereby approved, confirmed, and ratified.

Section 4: Effective Date.

This resolution shall become effective when passed by the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.




