

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE TOTALING AN AMOUNT NOT TO EXCEED \$61,574.00 FROM THE LAW ENFORCEMENT TRUST FUND - *STATE*, TO PURCHASE SWAT LEVEL TACTICAL VESTS AND RELATED ACCESSORIES FROM FEDERAL EASTERN INTERNATIONAL ARMOR AND WAIVING COMPETITIVE BIDDING, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE.

WHEREAS, the City of Hialeah Police Department's SWAT unit and Fire Department's SWAT medics respond to many scenes in which subjects are armed with various types of weapons, including high powered assault rifles; and

WHEREAS, the Hornet DXIIIA tactical vest and accessories will adequately protect SWAT personnel against various threats encountered during SWAT missions; and

WHEREAS, these tactical vests and accessories are innovatively designed to provide protection, comfort, and flexibility; and

WHEREAS, these tactical vests and accessories are intended for long term use; and

WHEREAS, the Hialeah Police Department requests to waive competitive bidding as the tactical vests and accessories will be purchased via the body armor State Contract;

WHEREAS, the City of Hialeah finds that it is not advantageous to utilize competitive bidding as the body armor State Contract with Federal Eastern International is active and already in place; and


WHEREAS, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Trust Fund - *State*; and



Federal Eastern International, and wave competitive bidding, upon such costs having been approved by the Chief of Police.




