RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING THE PURCHASE OF ONE (1) 2012 FORD EXPLORER WITH VEHICLE IDENTIFICATION NUMBER 1FMHK7D89CGA66981, FOR THE AMOUNT OF \$20,953.82; AND FURTHER AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY, TO NEGOTIATE ALL OTHER MATERIAL TERMS OF THE SALE AND EXECUTE ANY DOCUMENTS NECESSARY TO SECURE AND COMPLETE THE PURCHASE OF THE VEHICLE.

WHEREAS, the City whereby determines that an essential need exists for the procurement of a vehicle to be utilized by City of Hialeah Director of the Grants and Human Services Department in the discharge of that Department's obligations;

WHEREAS, the vehicle that the City intends to purchase was under a lease agreement between the City of Hialeah and Gus Machado Ford and the term of the lease has expired; and

WHEREAS, it has been determined that Gus Machado Ford offers the best economic value at a purchase price of \$20,953.82, and therefore the procurement of the vehicle is practical and makes financial sense.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The Mayor and the City Council of the City of Hialeah, Florida hereby approve the purchase of one (1) 2012 Ford Explorer with Vehicle Identification Number 1FMHK7D89CGA66981, for the amount of \$20,953.82; and further authorizes

the Mayor, on behalf of the City, to negotiate all other material terms of the sale and execute any documents necessary to secure and complete the purchase of the vehicle.


