RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, DIRECTING THE CITY OF HIALEAH PUBLIC WORKS DEPARTMENT DIRECTOR OR THE DIRECTOR'S DESIGNEE, TO PRESENT TO THE CITY COUNCIL EACH QUARTERLY AND ANNUAL REPORT REQUIRED TO BE MADE BY PROGRESSIVE SOLID WASTE SOLUTIONS OF FL, INC, PURSUANT TO THE TERMS OF THE EXCLUSIVE FRANCHISE AGREEMENT FOR THE COLLECTION OF RESIDENTIAL MUNICIPAL SOLID WASTE, WITHIN A REASONABLE PERIOD OF TIME NOT TO EXCEED TWENTY (20) DAYS FROM THE DATE EACH REPORT IS RECEIVED.

WHEREAS, it is the desire of the Mayor and City Council for the City of Hialeah to be informed and monitor the progress of the transition of residential waste collection services to private collection, the transition of manual collection to automation, and the overall quality and performance of the residential municipal solid waste collection services provided by Progressive Solid Waste Solutions of FL, Inc. ("Progressive") under the terms of the Exclusive Franchise Agreement awarded to Progressive on August _____, 2015 pursuant to Hialeah, Fla. Ordinance No. 2015-_____ (August _____, 2015); and

WHEREAS, Progressive is required to maintain various records and logs of its performance of the collection services and to submit to the Director of Public Works a quarterly and annual report summarizing its performance pursuant to the terms of the Agreement; and

WHEREAS, receiving the reports achieves the Mayor's and Council's desire to be timely informed of the progress, quality and performance of residential collection services by Progressive;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


Section 1: The Director for the City of Hialeah Public Works Department, or the Director's designee, are hereby directed to present to the City Council each quarterly




