

RESOLUTION NO. 2015-149

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING AND RATIFYING THE RENEWAL OF THE TURF AND LANDSCAPE MAINTENANCE JOINT PARTICIPATION AGREEMENT WITH THE STATE OF FLORIDA, DEPARTMENT OF TRANSPORTATION, FOR THE MAINTENANCE OF TURF AND LANDSCAPE ON DESIGNATED STATE ROADS WITHIN THE CORPORATE LIMITS OF THE CITY OF HIALEAH, FOR A TERM OF ONE YEAR, COMMENCING ON DECEMBER 22, 2015 AND ENDING ON DECEMBER 20, 2016, IN AN AMOUNT NOT TO EXCEED \$142,867.53, A COPY OF THE ORIGINAL AGREEMENT IS ATTACHED HERETO AS EXHIBIT "1".

WHEREAS, the State of Florida, Department of Transportation having jurisdiction over State roads has created median strips of the State Highway System within the corporate limits of the City of Hialeah as part of a continual State of Florida Highway System;

WHEREAS, pursuant to Hialeah, Fla., Resolution 2014-134 (November 13, 2014), the City of Hialeah entered into Turf and Landscape Maintenance Joint Participation Agreement ("Original Agreement"), where the State of Florida, Department of Transportation agreed to reimburse the City of Hialeah for the maintenance of turf and landscape of said median strips within the State of Florida, Department of Transportation's right-of-way for a term of one year, set to commence when the State of Florida, Department of Transportation provided the City with a Notice to Proceed, and with an option to renew, under the terms of the Original Agreement attached hereto and incorporated herein as Exhibit "1";


WHEREAS, the parties are authorized to enter into this Agreement pursuant to Section 339.08 (e) and 339.12, Florida Statutes; and

WHEREAS, the City of Hialeah finds that it is in the best interest of the health, safety and welfare of the community to renew the Turf and Landscape Maintenance Joint Participation Agreement to ensure the safety of the residents of the City as well as to improve the aesthetic value of the community.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The City of Hialeah, Florida hereby approves and ratifies the renewal of the Turf and Landscape Maintenance Joint Participation Agreement with the State of Florida, Department of Transportation, for the maintenance of turf and landscape on designated state roads within the corporate limits of the City of Hialeah, for a term of one year, commencing on December 22, 2015 and ending on December 20, 2016, in an amount not to exceed \$142,867.53, a copy of the Original Agreement is attached hereto as Exhibit "1".


