

ORDINANCE OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AMENDING HIALEAH, FLA. ORDINANCE 2015-59 (SEPT. 24, 2015) ADOPTING THE PUBLIC WORKS FUND BUDGET FOR FISCAL YEAR 2015-2016 TO APPROVE AND RATIFY A REDUCTION IN APPROPRIATIONS IN THE AMOUNT OF \$3,021,424 FOR A NEW YEAR-END PUBLIC WORKS FUND BUDGET IN THE TOTAL AMOUNT OF \$95,311,530; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, budgeted appropriations were reduced by an estimated amount of \$95,311,530; and

WHEREAS, this revenue was appropriated during fiscal year 2015-2016 in the manner set forth in the schedule attached as “Exhibit A”; and

WHEREAS, pursuant to Florida Statutes Section 166.241(4), the governing body of a municipality may amend a budget within sixty days following the end of the fiscal year; and

WHEREAS, the City now wishes to amend its fiscal year 2015-2016 Public Works Fund budget accordingly.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: Amendment of Hialeah, Ordinance 2015-59 (Sept. 24, 2016).

The Public Works Fund Budget for the City of Hialeah, Florida, for the Fiscal Year 2015-2016 approved and adopted by Hialeah, Fla. Ordinance No. 2015-59 (Sept. 24, 2015) is hereby amended by \$3,021,424 in reduced appropriations for a new year-end total Public Works Fund Budget in an amount of \$95,311,530. All supplemental appropriations for Fiscal Year 2015-2016 are hereby approved, confirmed and ratified.

Section 2: Repeal of Ordinances in Conflict.

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 3: Severability Clause.


If any phrase, clause, sentence, paragraph or section of this ordinance shall be declared invalid or unconstitutional by the judgment or decree of a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs or sections of this ordinance.

Section 4: Effective Date.

This ordinance shall become effective when passed by the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.


