RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, ACCEPTING A GRANT IN THE AMOUNT OF \$5,000 FROM THE BASEBALL TOMORROW FUND TO SUPPORT THE GROWTH OF THE CITY'S BASEBALL AND SOFTBALL PROGRAMS, AND AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO EXECUTE THE AGREEMENT ATTACHED HERETO AND MADE A PART HEREOF AS EXHIBIT "1".

**WHEREAS**, the City of Hialeah is continuously searching for available grants as a source of funding to support the maintenance and growth of its youth programs and expansion of services to the community; and


**WHEREAS**, the City finds it is in the best interest of the welfare of the community to support the growth of its baseball and softball programs by accepting this grant.







The Baseball Tomorrow Fund will pay \$5,000 within one month of receipt by the Baseball Tomorrow Fund of the executed letter of agreement, and the City of Hialeah Department of Parks & Recreation agrees that the use of grant funds will be completed on or before March 31, 2015. 
