

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE TOTALING AN AMOUNT NOT TO EXCEED \$47,860.62 FROM THE LAW ENFORCEMENT TRUST FUND - *FEDERAL*, TO PURCHASE TWO (2) 2013 HARLEY DAVIDSON ROAD KING POLICE MOTORCYCLES (FLHP) AND RELATED EQUIPMENT UTILIZING THE PRICING ESTABLISHED BY A COMPETITIVE BID FROM THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA FIRE CHIEF'S ASSOCIATION UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE.

WHEREAS, the Hialeah Police Department desires to purchase two (2) 2013 Harley Davidson Road King police motorcycles from Bruce Rossmeyer's Harley Davidson in Fort Lauderdale, FL, utilizing the pricing established by a competitive bid from the Florida Sheriff's Association and the Florida Fire Chief's Association Bid 12-20-0905.

WHEREAS, the Hialeah Police Department requests to purchase trunk mount radios from Motorola Solution's, Vendor number 12138.

WHEREAS, the Hialeah Police Department requests to purchase emergency equipment from rainbow Window Tinting, Vendor number 21914.

WHEREAS, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Trust Fund – *Federal*; and


WHEREAS, the Chief of Police has recommended adoption of this resolution and determined that the proposed expenditure complies with the provisions of Section 932.7055 of the Florida Statutes (2012); and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1. The Mayor and the City Council of the City of Hialeah, Florida, approve the expenditure of an amount not to exceed \$47,860.62 from the Law Enforcement

Trust Fund –*Federal*, for the purchase of two (2) 2013 Harley Davidson Road King police motorcycles from Bruce Rossmeyer’s Harley Davidson, utilizing the pricing established by a competitive bid from the Florida Sheriff’s Association and the Florida Fire Chief’s Association Bid 12-20-095 and for the purchase of sole source trunk radios from Motorola Solution’s and for the purchase of emergency equipment from Rainbow Window Tinting, upon such costs having been approved by the Chief of Police.


