

RESOLUTION NO.: 2013-63

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE TOTALING AN AMOUNT NOT TO EXCEED \$210,250.40 FROM THE LAW ENFORCEMENT TRUST FUND – *STATE*, AS FOLLOWS: \$183,820.00 FOR THE PURCHASE OF TEN (10) 2014 CHEVROLET IMPALAS (1WF19) POLICE VEHICLES FROM MAROONE CHEVROLET LLC, UTILIZING THE PRICING ESTABLISHED BY A COMPETITIVE BID FROM THE FLORIDA SHERIFF'S ASSOCIATION AND EMERGENCY EQUIPMENT WITH INSTALLATION FROM RAINBOW WINDOW TINTING INC. FOR \$26,430.40, UPON SUCH COSTS BEING APPROVED BY THE CHIEF OF POLICE.

WHEREAS, due to the transient nature of the criminal element it has been necessary to send Detectives across the state to the west coast and points north to investigate crimes; and

WHEREAS, the aging Police Department fleet is not dependable for long trips; and

WHEREAS, these vehicles will be used for trips outside of the southeast Florida area; and

WHEREAS, the Police Department wishes to purchase ten (10) Chevrolet Impalas from Maroone Chevrolet LLC, the lowest quote vendor, and wishes to purchase the necessary emergency equipment from Rainbow window Tinting Inc. to properly outfit these vehicles; and


WHEREAS, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Trust Fund - *State*; and

WHEREAS, the Chief of Police has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, Section 932.7055, *Florida Statutes*, (2012).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1. The Mayor and the City Council of the City of Hialeah, Florida, hereby approve the expenditure of an amount not to exceed \$210,250.40 from the Law Enforcement Trust Fund - *State*, as follows: \$183,820.00 to purchase ten (10) Chevrolet Impalas from Maroone Chevrolet LLC, the lowest quote vendor, and \$26,430.00 from Rainbow Window Tinting Inc. to purchase the necessary emergency equipment to properly outfit these vehicles for law enforcement use, upon such costs having been approved by the Chief of Police.







Dear Mayor Hernandez and Council Members:


The Charter of Hialeah states that contracts in amounts greater than \$15,000.00 shall be awarded on the basis of specifications and formal sealed bids. The Council may award a contract to the lowest responsible and responsive bidder, or it may reject all bids and re-advertise; or it may waive competitive bidding when it finds it to be the best interest of the City.

The Department will like to purchase the Chevrolet Impalas for the Criminal Investigation Division. The Criminal Investigation Department has an aging fleet that is not dependable for long trips. These vehicles will be used for trips outside the southeast Florida area.


We will use the Florida Sheriff's Association bid 12-20-0905. Fleet Director Anibal Rioseco will coordinate the purchasing and outfitting of these vehicles. The vehicle will be purchased from Maroone Chevrolet LLC 8600 Pines Blvd. Pembroke Pines Florida 33024 for \$183,820.00. The necessary emergency equipment with installation will be from Rainbow Window Tinting Vendor Number 21914 emergency lights, sirens, etc for \$26,430.40.

The balance remaining in the 105.1000.521.640 L.E.T.F. State account after this request is \$0, as of the agenda deadline. After a supplemental appropriation of \$210,250.40 into expense account 105.1000.521.640 and revenue account 105.1000.342.110




