

ORDINANCE NO. 2018-124

ORDINANCE OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AMENDING HIALEAH, FLA. ORDINANCE 2017-55 (OCTOBER 2, 2017) ADOPTING THE OPERATING BUDGET FOR FISCAL YEAR 2017-2018 TO INCREASE APPROPRIATIONS FROM TRANSFERS IN AND FUND BALANCE IN THE AMOUNT OF \$50,977 AND TO APPROVE AND RATIFY ALL UNENCUMBERED APPROPRIATION BALANCE TRANSFERS WITHIN AN OFFICE OR DEPARTMENT OR FROM ONE OFFICE OR DEPARTMENT TO ANOTHER FOR A NEW YEAR-END OPERATING BUDGET IN THE TOTAL AMOUNT OF \$144,150,977; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith; PROVIDING PENALTIES FOR VIOLATIONS HEREOF; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, budgeted appropriations were increased by an estimated amount of \$50,977;

WHEREAS, this revenue was appropriated during fiscal year 2017-2018 in the manner set forth in the schedules attached as "Exhibit A" and "Exhibit B;" and

WHEREAS, within the last six months of the fiscal year 2017-18 the City transferred unencumbered appropriation balances within an office or department or from one office or department to another as set forth in the schedule attached as "Exhibit B"; and

WHEREAS, pursuant to Florida Statutes Section 166.241(4), the governing body of a municipality may amend a budget within sixty days following the end of the fiscal year; and

WHEREAS, the City now wishes to amend its fiscal year 2017-2018 general fund operating budget accordingly.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: Amendment of Hiialeah, Ordinance 2017-55 (October 2, 2017).

The Operating Budget for the City of Hiialeah, Florida, for the Fiscal Year 2017-2018, approved and adopted by Hiialeah Ordinance No. 2017-55 (October 2, 2017) is hereby amended to reflect appropriations from transfers in and fund balance in the amount of \$50,977 for a new year-end total general fund operating budget in the amount of \$144,150,977. All appropriations within an office or department or from one office or department to another and all supplemental appropriations for Fiscal Year 2017-2018, not previously approved by Council, are hereby approved, confirmed and ratified.

Section 2: Repeal of Ordinances in Conflict.

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 3: Penalties.

Any person, business, association, corporation, partnership or other legal entity who violates any of the provisions of this ordinance shall be assessed a civil penalty, up to a maximum of \$500.00, within the discretion of the court or administrative tribunal having jurisdiction. Each day that a violation continues shall constitute a separate violation.

Section 4: Severability Clause.


If any phrase, clause, sentence, paragraph or section of this ordinance shall be declared invalid or unconstitutional by the judgment or decree of a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs or sections of this ordinance.

Section 5: Effective Date.

This ordinance shall become effective when passed by the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.






